

# AGREEMENT

for the provision of care services at the Principal's place of residence

The parties hereby agree as follows:

## 1

1. The purpose of this Agreement is to define the conditions under which the Caregiver provides assistance in Principal's day-to-day life at Principal's home.
2. The Contractor undertakes to delegate the following person to provide the service:

hereinafter referred to as the Caregiver who will participate in the performance of the commissioned work, which constitutes an integral part of the offer and this Agreement.
3. The Caregiver will provide the services specified herein, on the condition that:
  - Mr/Ms ..... provides accommodation and alimentation for the person for the duration of the Agreement (i.e. 3 meals a day),
  - ..... stays in his/her home and performs his/her obligations under this Agreement.

Taking into account the mutual promises contained herein, the parties, who wish to be legally bound, agree as follows:

1. Nutrition.

- a. Balanced meals – the Caregiver agrees to prepare three (3) nutritionally balanced meals per day, when such assistance is required. One such meal is served in the morning, one at noon, and one in the evening, and additionally an afternoon tea meal, if necessary;
- b. Special diet – special diets will only be provided upon the request of a licensed physician;
- c. Additional duties – the Caregiver agrees to go to the grocery store to buy ingredients for nutritious meals. After preparing meals, the Caregiver will provide assistance with feeding, if necessary, and after the meal, he/she will help clean the kitchen, including washing the dishes.

2. Cleaning.

The Caregiver agrees to provide cleaning services as follows:

- a. General cleaning – once a week;
- b. Making the bed;
- c. Doing the laundry / changing the bedlinen;
- d. Washing the dishes;
- e. Emptying waste containers;
- f. Sweeping and mopping floors, stairs and corridors without carpeting;
- g. Replacing the hygienic products in the bathroom;
- h. Keeping the bedroom neat and tidy.

3. Cleaning. On a daily basis, he/she will keep the house in a clean, hygienic and tidy condition. Mr/Ms..... should provide all supplies that are necessary for performing normal cleaning activities. The Caregiver should perform all regular and heavy housekeeping activities, as detailed above.

4. Help outside the home. The Caregiver should perform daily orders for ..... and these may include, among others, bringing clothes from drycleaners', shopping for groceries, purchasing basic necessities and (where applicable) washing and keeping clean the car .....

5. Personal hygiene needs. The Caregiver should regularly monitor the physical and mental states of ..... and, if necessary, s/he makes arrangements to meet the health needs by organizing a transport to the physician chosen by .....The Caregiver provides help to ..... in fulfilling the physicians' instructions, including storage, distribution, and reminding to take prescribed medications.

The Caregiver will also provide to .....personal assistance in bathing and getting dressed, body hygiene, hair care, shaving, eating, garment care, personal shopping and ancillary services, as needed.

- 6. Transport. The Caregiver helps in fulfilling transport needs by organizing public transport or assistance in especially provided transport for elderly people.
